#### Adhesive Performance

The adhesive is suitable for general application on a wide range of substrates, featuring good initial tack and adhesion combined with excellent removability. In addition the adhesive has superb low temperature performance.<BR>Remark: Application to porous substrates such as paper and board, or prolonged exposure to UV light may adversely affect clean removability. Removable adhesive, by nature, have a low cohesion and might be subject to variation in the product aesthetics which could be observed on the web rolls as long as the material is not used. We recommend to store the material with the inner core in vertical position after delivery.

#### Applications and Use

The product is suitable for a wide range of promotional and industrial label applications where brilliant multicolour print quality is required.

R100 removes clean from many substrates from polymeric ( PET, PP, ABS, PS), greeting cards, aluminium, stainless steel and glass ( not suitable for window labelling)

This glossy, coated quality is specially suited to provide top printing quality in all usual processes, whether single or multicolour, line or process colour printing. Excellent conversion characteristics in rotary and flat-bed.


#### Shelf Life
