Applications and Use

This product is ideal for applications such as event tickets, transportation tickets and boarding passes. This product is produced without the use of Bisphenol A (BPA).

Conversion and Printing

The product can be converted by all conventional roll conversion technologies including: Letterpress, Offset, Screenprinting, UV flexo and Water-based flexo. This product is also suitable for variable information printing in: Direct thermal printing systems at printing speeds up to 200 mm/sec (based on the printer's set up). The product has no backcoat, so printing on the non-thermal side is not recommended. IMPORTANT NOTES: Due to the thermographic properties, exposure above 50°C may cause premature imaging or discolouration. Inks containing alcohol or volatile organic solvents may cause discolouration of the thermosensitive coating. It is advisable to test inks and varnishes before conversion.

Shelf Life

To obtain optimal performance, use this product within one year of the date of manufacture, under storage conditions as defined by FINAT (20-25°C; 40-50%RH). Prolonged storage outside these conditions might reduce the shelf life.


