Adhesive Performance

S692N is a clear permanent adhesive featuring excellent UV resistance and weatherability together with good adhesion performance, even on apolar substrates.

Applications and Use

Applications are predominantly in food or home and personal care. Due to its flexibility the product is especially suitable for squeezable bottles and other flexible containers. The white matt finished film blends well with matt plastic containers.

Conversion and Printing

The product features matt topcoat that enables good printability and high speed conversion in conventional and digital printing. The topcoat is designed for optimal ink adhesion. The material has very good register properties especially when a high number of different colours is used. On-press corona treatment is not advised. The face material is suitable for Thermal Transfer (TT) printing. Exact inks, foils and ribbons should be specified by your ink/foil/ribbon supplier. According to internal testing best TT printing results are achieved with Wax & Wax/Resin ribbons. Care should be taken when applying cold foil; we recommend underprinting with a white ink layer for optimum result. This product shows good image quality in UV Inkjet printing. Care should be taken when printing small text; we recommend underprinting with solid colour e.g. white, to improve small text sharpness when printing with UV Inkjet. This product is not recommended for Xeikon dry-toner print technology.


