A white, cast-coated mirror finished woodfree printing paper, with block-out layer to give excellent opacity and a specific topcoating for excellent transfer and anchorage of ElectroInk as used in the Indigo process.

A general purpose permanent, acrylic based adhesive.

Liner rBG40 BROWN, a siliconized supercalendered glassine paper with 15% recycled (PCR) content. Being produced with recycled material, there is a possible higher incidence of impurities, visible fibers, and slight variation in tone.


